## **Background**

The District approved an Installment Purchase Agreement with Sterling Bank in December, 2020. The intent of that agreement was to finance costs from three large capital projects totaling approximately \$20.1 million. This report is meant to update the Board on the status of the agreement.

Staff prepared a statement with costs funded to date by the agreement. To date, a total of \$5.2 million of capital spending has been funded via the installment purchase agreement with the majority of those costs attributable to the CRA Project. This report is attached.
