1. **Call to Order.** An Adjourned Regular Meeting of the Board of Directors of the East Orange County Water District was called to order by WILLIAM VANDERWERFF, President of the Board of Directors, at 5:00 p.m. on Wednesday, February 26, 2014, in the offices of the East Orange County Water District, 185 N. A. **Introduction.** President VANDERWERFF said that with the resignation of DICK BARRETT, accepted February 3, a vacancy exists and the Board intends to fill it by

appointment. He very briefly introduced the proposed forum process for this evening, saying that each candidate would come up in alphabetical order and have 3 minutes to address the Board about their qualifications and interests in serving on the Board, followed by any questions and discussion Board members might have.

Candidates CHAPMAN, DENNY, EVERETT, MERINO, NELSON, SCHNEIDER and SEARS addressed the Board, commenting on their backgrounds and reasons for their interest in serving on the Board. Some of the candidates presented their thoughts on various issues facing the District such as water conservation, assumption of sewer collection and maintenance services and public education. Questions presented to various candidates included time-commitments and availability to carry out Director duties; familiarity with District; and other water issues and other involvement in community activities.


B. Selection Process. President VANDERWERFF thanked the candidates for their participation and said that the selection was on the Board's agenda for the following evening's meeting, February 27. He commented that the candidates were an impressive group of individuals and that it was heart-warming to see this level of interest in serving the District. He said it will be a very difficult decision for the Board.
